| • | Attendance: Two make-up classes are allowed per session. Please contact staff@velocitymusicacademy.com to schedule a make-up class. Initial Pick-up and drop-off: No one is available to watch your children before and after class. Please supervise children in the waiting room. Initial Registration fees: Your first invoice will include a registration fee for new students. The registration fee is due before classe start and is not refundable should you decide to not attend the classes. Tuition is based on 10 classes per session. You may also break up your 10-week session into 3 monthly payments via automatic credit card charge. Initial Tuition and Payment: Tuition for the first child is \$220 for the 10-week session, and includes materials (2 CDs, 1 Music Boo parent DVD, and Growth Chart). Siblings are ½ price, and the third child is free. Children under 9 months of age are free with paying sibling.
